In relation to the shares of GSD Holding A.S. 40 130% chareholding in total comprising 25 50% shareholding of M. Turgut Yilmaz 4 50% shareholding of MTY.

In relation to the shares of GSD Holding A.Ş., 40.139% shareholding in total comprising 25.50% shareholding of M. Turgut Yılmaz, 4.50% shareholding of MTY Delta Denizcilik İç ve Dış Ticaret A.Ş., 10.00% shareholding of GSD Holding A.Ş. and 0.139% shareholding of Adeo Turizm Otelcilik Ticaret Limited Şirketi are acting together.

3. In accordance with the Turkish capital Markets Board's Corporate Governance Principles, the shareholding of Mehmet Turgut Yılmaz in GSD Holding A.Ş., the controlling shareholder, amounts to 31.27% after eliminating indirect and cross-shareholdings.

Information on Privileged Shares

Voting Rights
